- Submit the NAMES AND ADDRESSES OF NEIGHBORS. Check with Clerk's Office for distance requirements.
- Submit a WRITTEN SUMMARY of the necessity for this action.
- Submit a copy of a SURVEY PLAT of the property to be considered. (not required for piers/raft permit)
- O Submit a written LEGAL DESCRIPTION in metes and bounds. (not required for piers/raft permit)
- O Submit 5 copies of all SUPPORTING MATERIAL, i.e. drawings, plans & written documentation. A minimum of three plan sets shall be full size, others must be reduced to 8 ½" x 11.
- File application with the Town of Waterford Clerk and Treasurers' office.
- O Pay application fee, NON-REFUNDABLE (For pier permits, fee is due upon receipt of permit)
- The Town of Waterford will not accept an incomplete application.
- O Submittal of partial or incomplete applications will not be considered for placement on the Planning Commission agenda until the application is accepted as complete and the appropriate fee is paid.
- Applications for PIER/RAFT PERMITS must include the following:
  - Construction Material & Color
  - Length and Width
  - Sideyard Setbacks
  - Water Depth
  - Drawing of the Proposed Pier
