Dear Project Stakeholder,

The Wisconsin Department of Transportation (WisDOT) is currently planning to resurface 3.5 miles of WIS 20 and WIS 20/83 between Honey Creek Road and Buena Park Road in the Town of Waterford and the Village of Waterford, in Racine County. The construction of this project is currently scheduled for 2024.

The purpose of this project is to address deteriorating pavement conditions and related deficiencies to extend the life of the pavement. The existing asphalt pavement is currently in poor condition and is showing signs of transverse cracking, weathering and rutting.

The project proposes to mill off 2 inches of existing asphalt pavement and place 2 inches of new asphalt overlay. Other work will include spot full-depth repairs, base patching, culvert repairs, signing and marking.

WIS 20 will be closed to through traffic during construction and a detour will be posted. WIS 20 will be open to local traffic and businesses during construction. Work on WIS 20/83 is expected to be completed using flagging operations.

Over the next few months, you may see WisDOT, consultant, or utility staff along the project completing preliminary investigations.
